Introduction

I would like to extend a big "Thank you" for agreeing to be a part of this event. It truly makes the event worthwhile when you provide products and support for the Trading Card Game community.

I am formally drafting a document that can be downloaded as a means of describing the details and formalities to maintain during the event. I will also include some expectations with the general audience [patrons] so they know how to interact at tables or during a tournament.

Admission

Attendees

There will be a booth setup to collect an admission fee for the event. The admission fee is \$5.

Attendees will receive a bracelet to indicate they have paid. The bracelet will allow attendees re-entry into the event if they vacate the venue.

Vendors

As official vendors for "Local Legends", you will be provided lanyards that serve as a Vendor Pass. This pass will permit your entry, setup, and breakdown of the event before and after the event's operating hours.



Setup & Breakdown Times

According to the lease agreement, the following times are intended for setup, the event hours, and breakdown:

The Floor Plan

The floor plan has been drafted by "General Exposition Services". This group is affiliated with the NJ Convention Center.

The draft below provides a projected layout of the event. As such, Vendor tables are designed to have five (5) six-foot (6') tables with three (3) in the front, one (1) on the left side, and one (1) on the right side. The back of the Vendor tables will be against the perimeter wall. It is strongly recommended that:

- All displays must reside within the confines of your area.
- Any structure brought to display artwork must be of sound construction and may not extend more than 5 feet above the table or a total of 8 feet from the floor, whichever is less.

The tables in the center are intended for tournaments. The table lengths in the center are eight (8) feet. It is estimated that three (3) people can fit on one side of an eight-foot (8') table.







Items Sold

Regarding the key products on the floor, it is important for Vendors to keep the following in mind:

- Vendors can sell original merchandise in the venue, so long as it is not unlicensed fanart or merchandise. Fan Art is defined as artwork based on popular works of fiction (such as books, movies, etc.) that is created by fans. What is determined to be fan art is at the sole discretion of CardBrokers LLC.
- CardBrokers LLC holds the right to ask a dealer to remove any item from their booth that we do
 not feel is appropriate for sale or for that vendor. This decision is at the discretion of
 CardBrokers LLC staff or the Event Organizer. This decision cannot be appealed.
- Anything that is illegal in NJ, or the USA is not permitted at Local Legends. It is the responsibility
 of the vendor to know all local laws. Failure to comply with laws and regulations will result in
 ejection from the venue without refund.

In addition:

- New Jersey State law requires that all Vendors selling taxable goods charge New Jersey sales tax separate from the amount of the sale.
- Vendors are required to be registered with the New Jersey Division of Revenue and Enterprise
 Services either before or after the convention and remit the collected sales tax to the State of
 New Jersey.
- All vendors must provide CardBrokers LLC with a photocopy of their NJ Certificate of Authority for Sales Tax (Form CA-1).



Conduct

- 1. While in the venue, ALL convention, local, state, and federal rules, policies, and laws apply.
- 2. Smoking, including vapes or electronic cigarettes, or use of alcohol or drugs while in the venue will not be tolerated.
 - a. Violations will result in removal from the Convention Center with no refund.
- Please refrain from running, screaming, yelling, horseplay, or obscene language; all Vendors
 are expected to be courteous and polite to one another, the staff, and other convention
 attendees.
 - a. Any unacceptable behavior towards a staff member will result in immediate removal with no refund.
- 4. Permission to video record your space, whether for personal or security usage will be given on a case-by-case basis. If you are interested in recording your space, you must do the following:
 - i. Send a formal request to <u>CardBrokers LLC</u> explaining your intention for the footage you plan to take. If approved post signage in clear view of the crowd with the following text: "WARNING Audio and Video Recording In Progress" If you plan to publicly release the footage you must have documented approval of those within the video to have their images shown, or their faces must be blurred

Ultimately, acting in a harmful or disrespectful manner towards Vendors, staff, or venue attendees will result in immediate removal and potentially other consequences by public authorities.



Disclaimer***

The Vendors and staff will work diligently to serve attendees and maintain a peaceful environment. We are by no means capable of tracking each attendee's whereabouts, transactions, or belongings within the venue. Any items carried into the venue are the sole responsibility of the attendee until consensually traded or sold to a Vendor or other attendee.

If an item is lost or stolen, immediately notify CardBrokers LLC staff. We will work with the convention staff and local authorities to mitigate the incident.
